


Magazine has decided to discriminate against barebackers by not allowing in their magazine any advertisements which contain the words "bareback" or "barebacking" or "barebackers".

Dear :

A meeting was held today by our Staff in regards to your decision to no longer accept ads containing the words "bareback". It is with regret that I have been directed to inform you that we are withdrawing all ads with your publication, which are currently running or scheduled to run. ALL CURRENT ADS ARE TO BE CANCELLED IMMEDIATELY.

We believe that your decision is arbitrary, capricious, and in the truest sense of the word, discriminatory. It is a decision that is a "slap in the face" against a large segment of our gay community who either choose to have condomless sex of choose to watch videos not featuring condoms, which, of course, is the absolute right of every informed, consenting adult.

As I pointed out to your representative, during our telephone conversation today, the act of barebacking is not illegal in any state, country or jurisdiction. To arbitrarily decide to ban a word simply because of your personal feelings, or due to the pressure of certain "condom nazi's", especially when it in injurious to a loyal and consistent advertiser such as we have been, is, simply put, wrong and is indicative of a serious lack of personal fortitude on your part.

While you may have the legal right to make such an arbitrary decision, we have the absolute right NOT to have to change the wording of our ads. We also have the right to choose NOT to spend our advertising dollars with you and to direct those funds to publications that do not practice such blatant and arbitrary discrimination. We also have the absolute right to let our customers know of your decision, as well as inform our business partners and

We are sorry that our relationship with has to come to such a distasteful end. But we will not support an organization that publicly promotes discrimination in any manner. I would direct your attention to what you wrote at the beginning of the 2001 Edition of your annual Directory where you stated: "The Web is about community, cooperation, competition, interconnectedness, individual freedom and responsibility..." I would suggest to you that your actions are NOT responsible, nor cooperative, and most certainly does NOT promote individual freedoms.


